Supervisor Chapell has been in contact with landowner Gary Goodwin and Surveyor John Nordquist, in regards to getting Gary's corner boundary pins reestablished; as they were apparently knocked out from grading operations. Where is this process at?
3. ATV/UTV Maple Ride is March 9, 2024.
4. There was a meeting for the public to review the draft copy of the Potter County Hazard Mitigation Plan, Wednesday, January 3, 2024 @ 6:30 p.m. @ the Gunzburger Building. Where is the county in this process?
